The Board of Directors of IFS Capital Limited ("IFS", together with its subsidiaries, the "IFS Group") wishes to announce that IFS (Thailand) has completed its initial public offer of 120,000,000 new shares (the "IPO Shares") at Thai Baht (THB) 1.35 (S\$0.056) per share and has today issued the IPO Shares. Subject to the Stock Exchange of Thailand ("SET") being satisfied that all conditions necessary for commencement of trading of the shares of IFS (Thailand) on SET have been fulfilled, the shares of IFS (Thailand) is expected to commence trading on SET at 10.00 a.m. (Thailand time) on 10 August 2010.

Following the issuance of the IPO Shares by IFS (Thailand), IFS Group's percentage shareholding in IFS (Thailand) has been reduced from 98.20% to 73.13% with effect from today.
